Join the move to affordable commuting

Your employer's commuter benefits solution can help you save money on eligible work-related transportation and parking expenses. And opting for mass transit helps reduce your carbon footprint while you save on commuting.



Choose how you roll

You can purchase passes or vouchers with your account's pretax dollars to cover the costs of traveling to and from work. Eligible expenses include costs for using bus and commuter highway vehicles, like vanpools; mass transit; metro and transit passes; token fare cards; and vouchers or fare for bus, train, subway, and ferry commuting.

Paid parking

You can use funds to pay for eligible work-related parking expenses at or near your worksite or at a location where you commute to work by mass transit, carpool, or qualifying vehicle. It also covers expenses for vendor parking lots and garages.

Don't forget to check with your employer about which accounts are available to you. These funds are only available for your eligible work-related commuting expenses; you can't use the funds for your spouse or tax dependents.

Flexible payment options


Once your funds are available, it's easy to pay for your eligible expenses up to the Internal Revenue Service (IRS) monthly limit.

- Use the Inspira Card™
- Pay for parking with cash, a check, or your personal credit card. Then submit a claim to pay yourself back.

Note: To purchase a transit pass with the Inspira Card, the provider must sell transit products exclusively in order for the card to work.

Key tips

- Get balance alerts and on-the-go access to funds with our online portal and Inspira Mobile[™] app.
- Monthly pretax parking and transit limits are set by the IRS. View the current limits on inspirafinancial.com
- Unused funds roll over into the next month: you can use your transportation and/or parking account to pay for eligible expenses up to the IRS monthly limit.
- Any unused funds in your account upon termination of employment are forfeited.
