

Dependent Documentation Requirements

If you enroll a spouse or child in medical, dental and/or vision coverage, you must provide documentation to verify the dependent's relationship to you. The chart below lists documentation required to enroll a spouse or child.

	<p>Common Law Spouse</p>	<p>Common Law Spouses must satisfy the following conditions:</p> <ul style="list-style-type: none"> • Must be in a committed relationship, and • Must be living together for at least one year with the intent to be life partners, and • Must be generally economically interdependent with each other. <p>The documents listed below must be submitted to enroll a Common Law Spouse:</p> <ul style="list-style-type: none"> • Affidavit of Common Law Marriage <u>and</u> Federal Tax Return within the last two (2) years <p>OR</p> <ul style="list-style-type: none"> • Affidavit of Common Law Marriage <u>and</u> Proof of Joint Ownership issued within the last six (6) months and shows names of team member and common law spouse: <ul style="list-style-type: none"> • mortgage statement • bank statement • credit card statement • utility bill • residential leasing agreement • automobile title or registration • property tax statement (last twelve (12) months is permissible) <p>Affidavit of Common Law Marriage (only if signed within the last 12 months). Proof of joint ownership is not required.</p>
